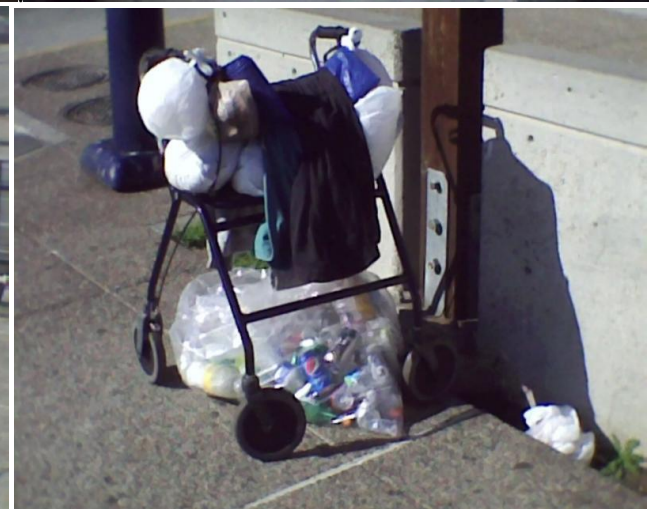
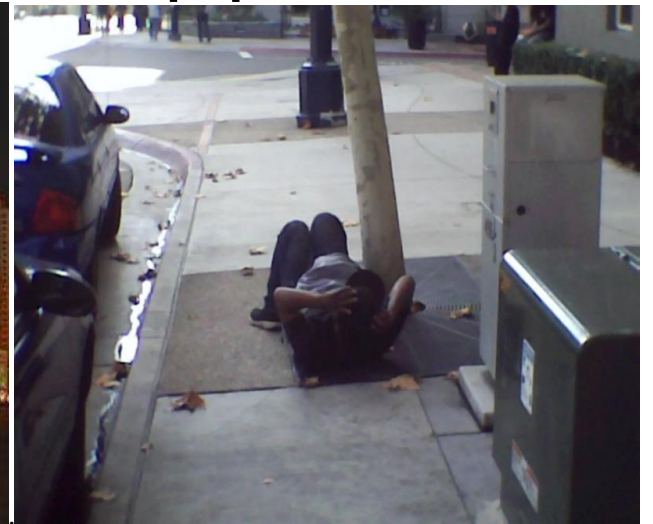

## Editorials:

**Comic-Con** is now in many cities, not just San Diego, and other cities are more convenient and less expensive to visit. So, our **Comic-Con is just for locals, and does not bring money into our economy.** We need to charge the Promoters more money for

this 4-day Informercial, which sells and advertises Hollywood products, and does not entertain anyone. Genius marketing, sort of like getting people to pay \$200 each to watch 4 days of "The George Forman Grille!", and Batman will sell you toy Batmobiles and DVD's, while Donald Duck sells you children's clothing and bath toys. As a marketing ploy, excellent, but as an entertainment event, not. It is a 4-day television commercial. **Can we pay these people to go someplace else?** You want to expand the Convention Center? Okay, should it be expanded into a Homeless Shelter or a Giant Warehouse? It is vacant most of the time, anyway.

**Toilets** were discussed by the Committee on Livability and Neighborhoods (see Meetings, below), and the City wants to get rid of the Portland Loo at 14<sup>th</sup> and K, and contract with Father Joe's for additional use of its toilets. Currently City pays for 5 men's and 5 women's toilets, 5:30 AM to 9:30 PM only, with a security guard, for \$80,000 a year. Currently, after-hours toilet use requires the outhouses one block west. I wish I could have given a better presentation, suggesting cameras or a Neighborhood Watch for the 14<sup>th</sup> and K loo, but speakers were required to wait 2.5 hours and then given one minute each. So, the City has already decided the issue and does not want good ideas. Typical. If you recall, we suggested a few years ago that commissioning existing toilets, rather than building new ones, would save money. ## Meetings:

**The Coalition For Basic Dignity - San Diego, (CBDSD)** met July 2, on a Holiday Weekend, as guests of the **Girls Think Tank (GTT)** with 12 present, including 3 Board Members of GTT, 4 homeless, 4 community leaders, and one in the news media. The three Board Members are attorneys. • The **Toilets Issue** is being discussed in City committees, with some saying that the Portland Loo on 14th and K is causing problems in the community. Much of this was covered in the July 1 Edition of the San Diego Homeless News,

The next meeting to decide the fate (maybe) of this toilet will be Wed., July 29 on the 12th floor of City Hall, 3rd and C, which is 2 days before the July 31 deadline for contract bids on the toilets for cleaning and repair. Comments were that the City numbers for costs do not add up, either as to the costs to install, nor the costs to maintain, and are excessively inflated. Two very interesting ideas emerged: One is to form a Neighborhood Watch for the toilets area, even enlisting the assistance of area homeless. They don't want dope being sold in their neighborhood, either, and have plenty of time to watch the loos. The other idea, even better, is to set up the Petco Park parking lot where this toilet is located as a Dreams For Change overnight parking spot, where homeless (with permission) park their cars and sleep in them, overnight only (gone in the daytime). •



The other item of interest is a new

pamphlet called "Know Your Rights", put out by the lawyers of the Girls Think Tank and distributed free to the San Diego Homeless. It is about 3 by 5 inches, 7 pages, color, and laminated, covering such issues as MTS, libraries, Illegal Lodging, Infractions, Misdemeanors, and Homeless Court.

#### **Mayoral Politics and the Godfather:**

It was revealed at the meeting that **Todd Gloria**, who could handily beat **Mayor Faulconer** and become Mayor, is being promoted to the State Legislature, so that State Assembly Speaker **Toni Atkins** can run for Mayor of San Diego and lose. (**Tony Atkins**, (D-San Diego) recently helped to pass a law giving us free identification cards.) Gloria needs to obey the Godfather, whom I call "Papa Gambino", because MOB support is necessary in all this. We consider Atkins a "Fake Democrat" because she and her wife, **Jennifer Lesar**, of Lesar Development, orchestrated the plans that made so many San Diegans homeless. Since, she is supposedly an "activist" for homeless issues, but not really, and we would oppose her election to any political office. This has us endorsing **Mayor Faulconer** as the lesser of two evils. The reasoning is this: The Republican Bar will screw you, but will be completely honest about that happening. The Democratic Bar is more "sneaky", trying to make it look like they give a shit.

**The Metropolitan Association of Providers of Social Services, MAPSS**, met July 22, with 25 present, an excellent showing. • The Jacobs-Cushman San Diego Food Bank will be organizing a Hunger Program December 1, information at [SanDiegoFoodBank.Org](http://SanDiegoFoodBank.Org). • The Salvation Army needs a Case Manager and also a Housing Specialist. [sandiego.salvationarmy.org/](http://sandiego.salvationarmy.org/) • The first presentation was on the **Homeless Outreach Team, HOT**. This is an Outreach Team, not a Social Services Program, operated by the San Diego Police Dept. They find homeless which are Class 1, 2, 3, or 4 (see Classifications, below) and try to find them a shower, clothing, mental health help, transportation, case management, or other services. **They no longer meet daily at City Hall.** They have a toll-free number to call for HOT services, **1-866-737-3468**. HOT consists of 4 police officers, a sergeant, 2 county health workers, and 1 mental health worker.

They do not do enforcement. **This is the first time in history that there has ever been dialogue between HOT and the Homeless Board.** We consider HOT to be a Public Relations team, because they are usually in on the secret daily media meeting. We have long suggested that HOT be a part of San Diego Fire and Rescue, instead of the police, because homelessness is something to be rescued from, not arrested for. It might also help if they were in plainclothes. We mentioned the Nazi leanings of the San Diego Police website, and our comments located at [www.NZ9F.com/Police](http://www.NZ9F.com/Police). • The next presentation was about **Volunteers of America**, which is a Social Services group, and NOT a placement agency for volunteers. The local group covers 5 or 6 counties. They provide help with behavior issues, such as severe mental illness, help looking for housing, substance abuse issues, treatment services, and they have beds for either males or females with severe mental illness. They have a detox program for substance abusers, and a stabilization center that allows up to a 6 month stay. They also help veterans who have a DD241, with any Discharge except Dishonorable. Bad Conduct Discharge is okay. • **Girls Think Tank** will be having a **Military Discharge Upgrade** seminar Sept. 4 at noon in the Downtown Main Library, 12th and K. It will be in the Mary Hollis Clark room, which is on the first floor near the entrance (behind the Friends of the Library sales area). •

**The San Diego Committee on Livability and Neighborhoods** met July 29. Kathryn Rhodes suggested that the City use parking meter money to pay for toilets, and also mentioned that the new \$100 million in approved projects meant over \$20 million in available property taxes, that could be used for toilets and/or Emergency Shelter grants. • **The San Diego Grand Jury** found that Downtown San Diego needs more toilets, and that it takes too long to install new ones. The City agrees. The Grand Jury also said that restrooms are difficult to locate, often not available 24 hours, and often unsanitary. They said that the City should develop, find, and implement additional 24-hour toilets that are clean, safe, well-maintained, and with attention to future needs. They said that the City should establish a budget to do this. And, they said that the City should cooperate with MTS, CalTrans, and Port of San Diego on toilets. To all of these, City says "Further Analysis Required". Okay, but we have now had all that "Further Analysis" for over 30 years, and went from 11 toilets in 2009 to now 4.

Our view is that the **Mayor's Committee on Toilets** repeatedly lied to its members, and the press, and inflated cost prices, and created engineering problems that they then cited as delays, and even intentionally chose very expensive toilets to discourage these plans from working. They also put one in a location, 14<sup>th</sup> and Market, that we went on record in advance saying the location would not work. Now, we would like to be a Party to IBA 15-31, toilets, to prove that San Diego intentionally wasted a quarter-million dollars of tax money in order to intentionally fail (as **Page Two** much as possible) on the

toilets issue. And, of course, the City is still quoting pie-in-the-sky prices for what it has spent or will have to spend. Lots of cities have these toilets, so why do they cost 5 times as much in San Diego? And, why do we have all sorts of problems that other cities do not? The 14<sup>th</sup> and K toilet is mostly used by patrons of Petco Park baseball games.

Lots of frustration, because the City does not care about what we said in the past, and also does not care what we are saying now. The City Cabal has come to its version of "Truth", and all City Employees are commanded to believe, conveniently supporting whatever decisions were already made for them. It smacks of Ancient Greece, where elected officials were used to explain to the public why taxes will be higher and wages lower. Todd Gloria wants help getting into the State Legislature, the Godfather wants to prevent downtown toilets, Father Joe's wants to make money, the politicians involved want public and media support, and all the real issues are obscured. Mexico has a government department referred to as the "Department of Public Confusion", which deals with PR.

We have billions of dollars for new condos, but not for toilets. Why did City force Fed-Ex (Kinko's) and CVS Pharmacy (both at 5<sup>th</sup>/6<sup>th</sup> and C) to be built with no toilets? Why are both the Toilets Issue and the Stadium Issue both still being debated 30 years later, along with the Mt. Soledad Cross?

I even irritated Chair Marti Emerald with my suggestion that City used toilets that were very expensive. What I meant was that they were \$80,000 to begin with, but City bid them up to \$200,000 before they ever bought one.

And, the Grand Jury has toilets findings, but even they must be watered down some. Intelligent poor folks, like Melanie Stuart, have been fired from the Grand Jury for knowing too much! Rachel Jensen, a prominent attorney with the Girls Think Tank, spoke, asking for reason. Good advice.

### **Excerpts from the Girls Think Tank "Know Your Rights" Pamphlet:**

**Bus & Trolley:** You can now get a S/D/M (Senior-Disabled-Medi-Cal) Day Pass from the MTS Transit Store at First and Broadway, Downtown San Diego, or any Albertson's Groceries. A one-day S/D/M Pass is \$1.25 and can be then re-loaded at all Trolley ticket machines! This is NEW. • Regulations prohibit pets unless it is a Service Animal or in an enclosure, on your lap. • Soliciting money and/or selling anything is punished by a \$250 fine and/or 48 hours Community Service.

**Panhandling:** In addition to staying away from Trolley and Bus loading areas and vehicles, it is unlawful to solicit while you stand or sit in a road or along a curb if that interferes with traffic, and all "Aggressive" solicitation (coercion, threatening, hounding, harassing, or intimidating) is a crime.

**Illegal Lodging:** If cited, you need to appear in Court, even if the ticket was issued entirely improperly. You are permitted to sleep on all City lands,

except Downtown, from 9 PM to 5:30 AM, 7 days a week. Downtown, you cannot be ticketed unless first being offered a free shelter bed.

**Infractions:** Similar to a parking ticket, you cannot be sent to jail for an Infraction. You also do not have the right to a Public Defender unless you are arrested and not released on bail. You may have to appear in person or have an attorney appear for you. You can be sent to jail if you do not appear.

**Misdemeanors:** You have the right to a Public Defender, and will get a written notice to appear in court. You must appear or a Warrant will be issued for your arrest. Special court sessions are held at homeless shelters.

## Proposed Classifications

We propose using these Classifications for types of homeless:

- 1.) Un-housed, living **outdoors**, in **plain view** (on display).
- 2.) Un-housed, living **outdoors**, **hidden** in parks, sewers, canyons, on rooftops, unsheltered.
- 3.) Un-housed, living **outdoors**, well-hidden and **sheltered** (tent, car, cave).
- 4.) **Semi-indoors** in inappropriate location or circumstances (garages, Tijuana slums, rooftop air conditioning units).
- 5.) **Indoors** very temporarily (**one day** or night).
- 6.) **Indoors**, with motel, friend, relative stay of **one week** or less.
- 7.) **Eviction Notice** received, with less than 14 days to vacate.
- 8.) **Evicted** and now has stove, refrigerator, bed, couch, television, clothing in a **storage locker**.
- 9.) **Longer-term** couch-surfing, motels, campgrounds.
- 10.) **Living with relatives** other than a spouse, as an adult child or parents with their adult children.
- 11.) **Living in** a homeless shelter, jail, prison, hospital, mental hospital, hospice, care facility, subsidized (Section 8) housing, free Reservation or

Ejido housing, transitional housing, or permanent supportive housing.

12.) Household (whether a family or roommates) **earns less than the HUD Minimum** to live in San Diego. Income includes all housing subsidies, SSI, Food Stamps, SSDI, pensions, Social Security, wages, etc., for the entire household. HUD Minimum for San Diego was listed at \$32 an hour, \$64,000 a year, which is \$1,280 per week, or \$5,500 a month. Inflation has raised this amount over 20%, however.

I am a Class 4-8 Homeless, and went in 2007 from a Class 12, to a Class 7-8, to a Class 2-8, to my present 4-8. **I have been Class 4-8 for years and will accept any help that does not just shift what Class I'm in. No luck.**

## Financial Advice:

It looks like Insurance, Banking, Internet, Small Universities, Recruiters, and Cell Telephone companies are taking a pounding, especially Health Insurance. Union Bank, AFLAC Insurance, Prudential Insurance, and a big handful of the IT companies are having trouble finding and retaining employees, especially in sales. The healthcare industry outside of health insurance is also having a tough time finding help. All this is not surprising because of the impacts of ObamaCare and free cell phones for those who qualify, plus most folks in IT and sales hate their jobs.

## Why Me?

**Coincidences, my whole life:**

Why Me? I have had a very unusual and fascinating life, full of millions of coincidences. If you go out to the store to buy a carton of milk, you might run into a stray cat, or a homeless man on the sidewalk, but if I go to the store I may very well run into things a lot more unusual than that. I have always

wondered if unusual coincidences happen to everyone, or just me? Some attribute this to Mental Instability, others to luck, and most to coincidence. Well, it seems to me that luck and coincidence are the same thing, but when that gets way too unusual and way too often, then what is it? I do have some minor mental illnesses, but everybody does, and none of them have anything to do with seeing reality incorrectly. I recently got an answer, maybe, but I do not believe the answer I got. I say in my Blog that I have met with the ET guys (intelligent beings from other planets) since age 3, and that is unfortunately true.

### **Meeting the ET folks:**

While on a camping trip with my parents in Northern Wisconsin, I went walking to the Lake Metonga Spring in Crandon, as a little boy, and ran into a very unusual sight, a landed UFO. I was only 3 years old, so I did not have a clear conception of the difference between a movie alien and a real one, so I was not afraid. They spoke with me, telepathically and also in voice, and made me understand that they are not bad people, and they want to teach me some things. They put something into my head, but it didn't hurt. As far as I know, I never saw these particular guys again. That was in 1955.

Did the nice aliens know that the little boy was Autistic? Sure, but there was no such disease known in the 1950's. Autism is being born with so much Genetic Memory (intelligence) that it overloads the brain. ADHD, Attention Deficit-Hyperactivity Disorder did exist, and it is low-level Autism.

There are enough military people in San Diego, and even a handful of Librarians, who will discuss the other planets with you, because their existence is no longer Classified. In the past, if you even knew this information, unauthorized by our military, they killed you. A whole lot is still Classified, but some of the basic stuff can be discussed, as long as no proof or evidence is provided in any way. This leaves ordinary folks the out of thinking that you are just daffy, if they care to believe that.

### **Grade School and Being Too Intelligent:**

4 years later, I became a religious victim of Catholic grade school (8 years), involving the extreme use of Human Spirituality, which was the result of being excessively intelligent. Off the range of normal I.Q. tests, I was administered special tests by several nuns over several days. One nun came to me in secret and said that if I continued to score so high, I would be given drugs and surgery to make me less intelligent. Heeding her warning, I blew the rest of the tests. I was given very abusive amounts of Holy Communion and Kosher school food for 8 years, age 7 (1959) thru age 14 (1966). I was also subject to frequent attempts of the priests and nuns to take me to bed, but that only taught me that there is no God. I was an Atheist by age 14, and when I enrolled for college at the University of Wisconsin – Milwaukee, four years later (1970) listed "Atheist" as my religion.

### **Becoming Victimized by the Bar: Page Four**

In 1982 the Bar and the Milwaukee City Cabal hired actors, used unlawful wiretaps and room eavesdropping devices, bribed news reporters, arranged to have expert witnesses lie, coached several real witnesses to lie, coerced and threatened witnesses for my defense, tampered with both the jury and evidence, and even made a deal with my attorney, just to convict me unjustly of Fraud, causing me to lose my \$25 million to \$40 million heating and air conditioning business. (Insurance Appraisal by Employers Mutual of Illinois Insurance Company). This constitutes the Bar and Cabals engaging in a Conspiracy to Obstruct Justice.

It is true that NBC-Trane needed a scapegoat because there were heating and air conditioning companies (like them) financing equipment that homeowners could not afford, and then foreclosing on homes. Of course, NBC-Trane wanted to point the finger at somebody else. I worked for them as a salesman in Kearny Mesa, a neighborhood of San Diego, and quit because the scam they ran was unethical. That is how I know about it. I personally made sure we ran no such scam, yet got convicted of doing so.

NBC-Trane started a media blitz that made me look like a criminal, biasing any potential jury. I got sent to prison, and have now been homeless 33 years as a result of all this. I continue to hold the Moral High Ground, and even use Comic Relief to insist that a Criminal Lawyer is a Criminal who became a Lawyer, and that the Bar Association is a league of tavern owners. I was really such a sucker that I thought the legal system and news media were on the up-and-up. I never really went back into business, because I learned that the whole thing would just happen all over again. The corruption would guarantee me a lifetime of poverty. **You can only make money by inheriting it or stealing it.** I give the whole story at [www.NZ9F.com/Me](http://www.NZ9F.com/Me).

### **What Caused the Most Damage and Concern:**

**What tore me up the most** over losing my \$25 to \$40 million business was not going to prison nor becoming poor, because I can just start another business and recover all that. What it taught me, though, is that the news media, courts, police, governments, the entire system is corrupt, and that if I established a different business, it would just be taken away from me the same way: Fake evidence, fake testimony, fake charges, and the Mormons offered to buy all of my in-stock items for discount prices. So, there is no solution through self-employment. You heard otherwise? You may have heard part of the story, but keeping your head full of bullshit is the main thrust of society. Who would try to operate their own business, no matter how innovative, if it were a lost cause?

That, the prevalence of corruption to the point where it rules everything, is what tore me up mentally. My morals, values, dreams, beliefs, and aspirations became heavily compromised. At least 200 lawyers conspired in all this, and also knowing me to be innocent, so I need to sue the Bar or the Legal System. Prove

to me that when the Bar gets caught, it makes good on Restitution and/or proper Damages. Some folks are more visible to me than others, but to say they are to blame would be making them scapegoats. Unacceptable. The Expert Witnesses who lied have all apologized, but some took years before doing so, and all of them said they were threatened with grief if they did not cooperate. I know how that is, because I was often an Expert Witness myself, when I operated my private police agency, years earlier, and one day the District Attorney asked me to lie under oath. I refused, ending my police career. I charge the Bar with Intentional Felony Obstruction of Justice, with no Rules of Evidence nor for Computation of Damages relevant. Those are Bar constructs. I am asking a cash settlement of \$3.5 billion (as of July 2015) or \$4 billion late December 2015, increasing one billion dollars a year until settled.

### **Update to the Present:**

I was having a really awful time recently with my health insurance company, the State of California, and the Social Security Administration, and asked the ET Community for help. What followed was very interesting. We humans are not even supposed to know they exist, of course, but San Diego is a Navy town, and lots of folks here do a lot of work with them. As long as no "proof" ever leaks out, you can talk and write about anything you want. I was very angry, and I never, ever, get angry. Ask anyone. What surprised me is that the ET folks said this was a Planetary Emergency, and I told them that it was not, just some problems I'm having. I wanted to see if I could get help from the Planetary Guardians. They then told me that I am one. Big shock, but it explains all the strange stuff that goes on in my life. Really dangerous, because such beings are often killed on ape-like planets like SOL4 (Earth). I thought back at all kinds of absolutely impossible coincidences. Do I believe any of this? Well, I do not believe that I am important enough to rate any kind of a "Planetary" emergency, much less a Planetary anything.

### **The ET folks are Liars:**

And, the ET folks have lied to me before. They circulate stories that since they are telepathic, they cannot lie to you because their thoughts would give that away. Bull. They lie even more than the police, lawyers, governments, universities and the news media. So, I believe none of this. They once showed me a huge laser light display in the sky, explained that as "God", and expected me to believe, which I did. No doubt they may have shown Moses, Jesus, even Joseph Smith of the Mormons this sort of thing. I wrote a web page on that, [www.NZ9F.com/God](http://www.NZ9F.com/God), describing what I saw. The sky was filled with colorful strands like spaghetti, each one giving off light, sort of like cyalume (brightstick) necklaces intertwined. The whole thing turned out to be a laser light show, and spawned the Facebook site of the "Flying Spaghetti Monster". Meatballs please, and extra garlic.

The UFO guys tried to abduct me in 1989, when I was camping in a

Wisconsin State Forest. Alone, I observed a UFO landing, and we chatted. They asked if they could take me with them, and I told them that Earth was the only place I have ever known. 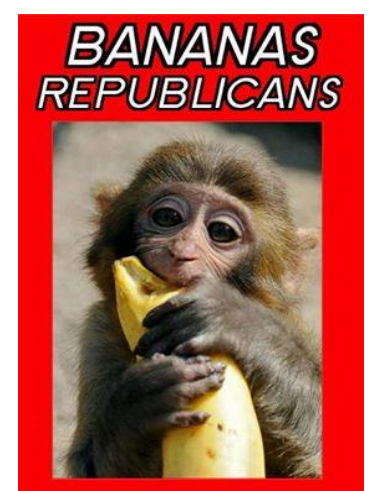
