Organized Crime in San Diego Operates Real Estate

Downtown Partnership, "Harass & Intimidate" (Clean & Safe) Sued By Cory Briggs - Probably Crimes By City Cabal Will Become Exposed

San Diegans For Open Government, through Briggs Law Corp., claims that the San Diego Downtown Partnership (Clean and Safe and the Downtown San Diego Property and Improvement District) mis-spent or unlawfully spent a lot of taxpayer money, thus cheating the taxpayers. It is our position that Clean and Safe is used to harass and intimidate homeless downtown until they eventually commit suicide. The lawsuit does not go into that, citing State Law 36600, which governs what is considered valid expenditures for a tax district. Much goes back to 2005, and both the entire list of the parties involved in this tax scam, and the dollar-amounts, have not yet been determined. This is a Class Action suit on behalf of the taxpayers against Organized Crime (assuming the misuse of taxpayer money is a crime), and is sure to expose many violations of Criminal Law, including involvements of the City Cabal and the City. Likely, no one gets prosecuted, because our current government is too corrupt to prosecute its own perpetrators. Tip of the iceberg for our gangster-controlled Mafia real estate machine in San Diego, which makes so many people homeless.

Can an ordinary lawyer, who is not the District Attorney nor the Attorney General, file Criminal Charges? What about a Criminal Class Action Suit? What happens if all the Prosecutors who could become involved are too corrupt? Editorial on "Jobs Tax"

The voter defeat of what the Mafia News Media called the "Jobs Tax" actually accomplished the following: You voted for **more homeless; higher expense to the City** for dealing with same; **increased corruption** in the form of secret deals made by the "Good Olde Boys" of the MOB between the City, construction firms, unions, governments, the news media, lenders, and developers; more **power for the Cabals** (the secret conspiracy groups that place their blood and semen into your food to control you for the Mafia); **higher OTHER taxes; decreased City services; higher rent prices; less small business; fewer jobs;** and each job paying **less money**.

Now that you have voted for all that, we poor have to sue the City for what we are owed, and what we need to survive. This will cost you, the taxpayer, a huge amount in higher taxes and fewer City services, but you wanted it, brainwashed by the news media. This issue of the San Diego Homeless News lays out what we need, and some of these things will be needed this year. **The more lies we are told, the fewer lies we believe, so we already do not believe that San Diego will do anything at all that it promises to do.** Nothing in here is in the City Budget, because San Diego does not work that way. It pays whatever it is forced to pay in court. End of story. I did not invent this type of government, Adolph Hitler did. Unfortunately, our legal system is far too corrupt for either law nor truth to prevail. And, lawyers take an oath to the Bar (Mafia) to secretly further that organization's interests. Actions Being Taken

I met very briefly with Mayor Falconer on Thursday, June 19, and admitted that, so far, he is the only Mayor that I have not criticized the policies of from the start. I was even critical of Mayor Filner. Some say that the Falconer-Alvarez election was rigged, and adding to that theory is the fact that some of my media moles said that the fix was in for Alvarez, which may have been to hide the fact that it was really in for Falconer. Ray Lutz, on Facebook, is assembling a vote-count monitoring program, especially since our current vote counter has a past history of involvement with cheating on vote counts.

Our success and survival will depend upon making it **excessively expensive** for the City to maintain such **high housing prices**, such a high **percentage of homeless** which results, and such a lack of **taxes and regulations** for those who develop real estate and **cause homelessness**. This will take time, but only recently did I see the whole picture. This will take lawsuits, concessions from the City, then additional lawsuits, and hopefully not take civil disobedience, such as shitting in front of tourists.

You are better than I am at doing this, provided you can maintain a Search Engine website, a small university, represent the homeless in the local and national media, run the homeless Cabal, operate a food pantry in Tijuana, publish 2 newspapers dealing with local and national homeless issues, and provide psychological counseling, all on about \$40 a month. Failure is a given, and inevitable, but I take projects that can only fail, trying to see how far I can get them before that happens. Most folks only take on projects with some chance of success, but that severely limits what gets done in the world. These are our demands:

PAGE THREE

The Ten Commandments

(with apologies to Moses):

1.) Communications and Posting: We get one bulletin board at the Third Ave. entrance at City Hall. **(Not very important, just goodwill.)**

2.) Toilets: We get 8 in the Trolley Loop and 3 north of the Trolley Loop. Existing toilets in 24-hour facilities are okay, and should have a sign like this: "Welcome to San Diego! To better serve our guests, the toilets in this Establishment are public, contracted by the City, and you may use them whether or not you make a purchase." **Somewhat negotiable, but toilets outside of these areas or within 3 blocks of another toilet don't count.**

3.) Neil Good Center gets additional night lighting, overhead canvas canopies to protect from sun--rain--and the view from high-rise apartments, and is now open 24/7 as a **Homeless Intake Center**, with hot showers, flush toilets, television, rest areas on the grass, and laundry facilities, all 24 hours. **Not negotiable.**

4.) The Rubber Tent Shelters will expand to three shelters, all open year-round, the third tent in Ocean Beach. The Barrio Logan tent will move to Downtown within two years. **Not negotiable, except that last sentence.**

5.) At least 10% of all buildings which were constructed with Redevelopment funds will be dedicated to serving the poor. No "housing credits" in another building, nor "slush funds" for "Affordable Housing". **Original building only**, no "Separate But Equal" housing in an inferior building in a ghetto neighborhood! **Affordable Housing** is to be defined by law as **"That housing which permits a tenant to have \$1400 of their income left over, after paying rent."** This is to be cost-adjusted monthly for Poor Man's Market Basket inflation. **Absolutely zero percent negotiable, and fight to the death.**

6.) Neighborhood Rights: No person made homeless by their home or hotel being torn down shall be required to move more than one city block from that location. **Not negotiable.**

7.) San Diego County will provide MTS bus passes or fares for job interviews, medical appointments, laundry, food, and libraries. **Negotiable.**

8.) Six storage areas for the poor and homeless open 24/7 in Downtown, Barrio Logan, Midway-Rosecrans, Ocean Beach, Pacific Beach, and Old Town. In the future, a seventh area in Mission Bay Park. **Negotiable.**

9.) No fees will be charged for any program, except rent in accordance with local Affordable Housing laws, Item 5. **Negotiable.**

10.) Homeless Administration Center: The City and County jointly will construct a Homeless Administration Center, downtown, which has a dining hall for 1,000, commercial kitchen, microwaves and gas barbecue grilles for homeless to cook their own food if desired, vending machines at cost (not for profit), 200 parking spots for those who live in their vehicles, a grassy area to relax, toilets and showers, cellular telephone and laptop computer charging, wi-fi, 6 on-line internet computers, laundry services, and dressing rooms to prepare for job interviews. All 24/7, and City-County shared, because most County homeless are forced to move to City, like I was. **Largely not negotiable, except perhaps as to exact services, and time of construction.**

PS: We are also asking for one day a week off, during which we do not work, and will be calling that "Sabbath".

Class Action: Past, Present, and Future

The ONLY thing that has ever been a success to fight for our rights, SO FAR

Our only advancements as far as **Human Rights Issues** have been the result of Class Action Lawsuits, or the threat of bringing same. Nothing else has ever worked at all. We sued to avoid being harassed and deprived of sleep overnight, **PAGE FOUR** sued to get the rubber tent shelters,

and sued to get medical care and food. We sued to get a Homeless Storage Program for our belongings. Now we need to sue for toilets, access to our traditional trolley-loop area, a Homeless Administration Center, and our rights to 10% of all housing funded by Redevelopment money. We are assembling a laundry list of things (see above).
Some History:

Mayor Maureen O'Connor was threatened with a lawsuit because of lack of shower, storage, television, and laundry facilities for the homeless, years ago, and realizing that the City would lose the lawsuit, established the **Neil Good Center**. City would have instead had to spend at least 3 times the money and services if that lawsuit had gone through, instead of the abysmal, inadequate services it now provides. They also saved the costs of the lawsuit itself. Neil Good was intentionally situated in a location where it can never be expanded without moving the Interstate 5 Freeway. If it were open 24/7, it would be an okay Homeless Intake Center, but it is way too small to ever become a Homeless Administration Center. Even just as an Intake Center, this would require additional lighting, and canopies to protect from sun, rain, and the view of high-rise apartments. The purchase of nearby real estate could also be required, to avoid being sued by the owners due to continuous inconvenience. I envision a second-story bridge over 17th St. to buildings across the street, which would be City housing or Administration buildings.

I want to see a **San Diego County Health and Human Services Homeless Administration Building** at the old El Cajon Police Station, on Broadway and Graves St. in El Cajon, too. Plenty of grass to relax on, and plenty of fenced-in parking for those who live in their vehicles. The City of El Cajon's mistreatment of the homeless for many years deserves this gesture, of course. As for the El Cajon Transitional Living Center, near East Main and Broadway, well, it seems to be for religious nut-cases who are hypnotized into spewing out Jesus-Bullshit. Not for real people. My plan would not remodel the old police building, just hold it, until real estate crashes and poor people no longer need it. Who would buy in now, anyway? Real estate is in

trouble as people keep getting less and less stupid. Blame the internet.

After Neil Good, the **Right to Sleep on City Property** took 3 years in court, and had to be changed to the courts in San Francisco because of threats and intimidation locally. And, the rubber tents were a different but similar lawsuit. I cover the Homeless Storage issue in the May 21 Edition of the San Diego Homeless News, at www.NZ9F.com/SDHNarchives2014/May. That issue is on Local Politics. Other lawsuits sued for food and medical care, and we do now need to sue for drinking water and our 10% share of the Redevelopment housing. An "Affordable Housing" plan is "Separate But Equal", where we get **inferior** housing in a **Ghetto** Neighborhood, instead of nice housing in the buildings built with Redevelopment funds. **UNACCEPTABLE**.

The reason my original Redevelopment article quoted in the May 21 edition (linked above) was not published in the San Diego Homeless News is that it pre-dates the founding of the newspaper. Back then, I was a reporter for Yahoo! News and the Associated Press, part-time and independent. I will now be preparing a list of grievances against City, County, State, Nonprofits, Redevelopment Agencies, Housing Authorities, Lenders, Materials Suppliers, Cabals (Secret Conspiracy Organizations, see the issue linked above for May 21, 2014), Bribe Money Donors, Community (Mis)Leaders, Construction Firms, Labor Unions, Transit Authorities, Government Associations, and more. Just a "laundry list" of how we poor and homeless have been greatly wronged for a very long time.

It is my hope to have Cory Briggs and Robert Scott Dreher both represent us in a colossal class-action suit that covers all bases and has many Defendants. Both lawyers have won everything that they have ever touched for us, handsomely, and their skills and expertise complement each other very well. Dreher knows San Diego politics well, and got us our "Right to Sleep Overnight Unmolested" ruling in the Federal Court System.
PAGE FIVE Briggs has a similar successful track

record, having successfully sued Cities and major corporations. They would be up against infamous City Attorney Jan Goldsmith ("Felony Hopscotch") who orchestrated having the Mafia remove Mayor Bob Filner from office, using the Cabals, News Media, and MOB influence in the legal system. As I often explain, the Cabals are secret conspiracy groups that run everything, not just the government, and they place their blood and semen into the food that everyone eats, to help to control them. Hedges, from Jerry Ashton on Facebook, via Occupy Melbourne: There are some essential lessons we can learn from the student occupation of Beijing's Tiananmen Square, which took place 25 years ago. The 1989 protests began as a demonstration by university students to mourn the death of Hu Yaobang, the reformist Communist Party chief who had been forced out by Deng Xiaoping. The protests swiftly expanded to include demands for an **end to corruption**, for **press freedom** and for **democracy**. At their height, perhaps a million people were in the square. Meetings:

Metropolitan Association of Providers of Social Services (MAPSS) met Wednesday, June 25, with 25 present, which is average. • There is a job open in food distribution at Jewish Family Services. • One featured topic was the Consumer Center for Health Education and Advocacy, which handles problems related to healthcare access. These include dealing with CMS, CCS (California Childrens Services), and Medi-Cal. They help with **Eligibility and Enrollment**. Mental health and dental are new added benefits. There is Covered California, plus an expansion of Medicare. To qualify for no-cost medical care, you must earn Minimum Wage full-time, or less (\$8 an hour, or \$16,000 a year). CMS can help, even for those who earn up to \$28 an hour, if needed such as a million-dollar operation. • **The August meeting will be cancelled, and instead there will be a presentation Aug. 27 on dealing with Volunteers.** This is ONLY for professionals who work training volunteers, and will cover setting boundaries, retaining good volunteers, self-care for social work, recruiting, training, and dealing with difficult volunteers. More will be discussed at the July meeting. • Gilbert Jimenez, who works for **PAGE SIX** San Diego County CalFresh and

General Relief said that right now there are **free workers available for your nonprofit or help agency, from WorkFare**. These are persons who need training and temporary work experience and are currently on welfare. They receive transportation expenses. WorkFare is at 1255 Imperial Ave., #446, or contact the El Cajon, South Bay, Oceanside, or San Diego Metro offices of Health and Human Services, San Diego County.
